COMMUNITY IMPACT



Fiddler Project

A grant from the community foundation's Heritage Fund helped the **Lindsborg Swedish Folk Dancers** (LSFD) purchase a string bass and a battery-powered bluetooth speaker with two microphones. "The Lindsborg Swedish Folk Dancers are so very thankful for financial support from the Smoky Valley Community Foundation," said grantee Melinda Hansen. "SVCF support, encouragement and recognition of the LSFD members make a positive and profound statement to the youth of Lindsborg."



Who's Your Neighbor

With help from a community foundation grant, the KICK (Kids in Christ's Kingdom) program at **Messiah Evangelical Lutheran Church** was able to host a "Who's Your Neighbor" class to teach students about diversity and other cultures. The grant also supported free, healthy meals for families, hosted by the program.

Art Education

The **Lindsborg Arts Council** received a community foundation grant to help send Jenny Davis to the National Art Education National Conference. She was able to attend many workshops, classes and speaking events about art education, which she has worked to implement in the community through various workshops. "The conference was beyond my expectations," Davis said. "I came back with some great ideas!"



Landmark Concerts

The **Lindsborg Landmark Concert Series** provides free musical concerts at unique venues in and around the community of Lindsborg. Grant funding from the Smoky Valley Community Enhancement Fund and Heritage Fund helped pay the performing musicians.

"The foundation grant allowed us to expand the number of concerts in 2018, and we were able to increase our audience size at all of our events," said grantee Mike Dreier.





Siren in Falun

The community of Falun now has an emergency storm siren, thanks to support from a community foundation grant and many other entities. The grant helped with installation costs. "Our community's safety has greatly improved by the storm siren and it has the potential to save many lives," said grantee Terry Mattison.



Chess School Carpet

The Anatoly Karpov International School of Chess received a grant to help replace 15-year-old carpet in their facility, which is home to the biggest chess library in Kansas. "Now, we have the beautiful new carpet, which changed the view and the first impression of the school," said grantee Anastasiya James. "Students and parents were very excited to have lessons in a freshlooking and clean school."

Filling Fountain

A community foundation grant helped the **Lindsborg Community Library** purchase and install a new water fountain with adult and child fountain heights, as well as a reusable bottle filler function. "The most notable success of the project has been the dramatic change in drinking water usage at the library." said grantee Suzanna Swenson.





Automatic Doors

A grant from the community foundation allowed **Bethany Home** to install an automatic door opener on the south side of the building to create a more accessible facility. This has been a blessing for frequent visitors like Laura Slagle. "I live in the Bethany Home Cottages to be close to my husband, Don, who is in the home," she said. "I used to have to call staff and have them meet me at the door, so that I didn't have to face the cold north wind and walk around the building. Now, I can access the building without bothering staff or being in the weather longer than necessary."

Donor advised funds are a popular option, as donors have the ablity to recommend grants from their fund to charities and pass their fund to future generations! These can be started by individuals, families, companies or by the rollover from a private foundation.

The foundation ensures viability, compliance and qualifications of recommended grant recipients.

CHECKS ISSUED:

The foundation can issue a check in any amount (\$250 or more) to any qualifying organization in the United States.



TRANSFER OF WEALTH

You've enjoyed a good life in a great community. What will you do to ensure the future Smoky Valley generations can say the same?

Do you know anyone who was born and raised in the Smoky Valley area but has since left for a bigger city? Chances are, when this person's parents pass away, the money in their family's estate (which was built in our community) will leave this area forever. By designating just **5% of our estates** to our hometown needs, we could create **permanent funding** to support our schools, hospitals, parks, churches, nonprofits, libraries and so much more! It just takes a little bit of planning.

According to the Kansas Association of Community Foundations:

In McPherson County, \$952 million

will pass from one generation to the next by **2029**.



5% of that, or \$47.6 million could be preserved in a foundation endowment.



This would create \$2.1 million in annual grants to benefit our community.



PLANNED GIVING

Planning your charitable legacy is simpler than you may think. Donors often establish charitable funds through deferred-giving arrangements—gifts that are planned today and realized upon the donor's passing. There are several ways to support the foundation with planned giving:

Charitable Bequests:

In your will or trust, you direct all or a portion of your estate, including certain money or property, to be transferred to the community foundation.

Life Insurance:

The foundation can be named as the irrevocable beneficiary of your life insurance policy. You can give a paid-up policy or continue to pay premiums.

Charitable Trusts:

Although the foundation does not serve as a trustee for charitable trusts, you can work with your professional advisor to set one up and support the foundation.

Need help with your estate plan?

Professional estate planning services are offered at **no charge** through a partnership with estate planning attorney John Griffin of Stewardship Counseling, LLC.

Once a month, John travels to Salina and provides comprehensive guidance to individuals and families who want to create or update estate plans that minimize potential gift, income and estate taxes. He helps develop the plan; then families work with their local attorney to finalize and file their documents.
